In this case, the State did not offer direct evidence as to what occurred in petitioner's former home while he was present, but did introduce evidence that petitioner had told both Powell and McDonald that he had killed someone. The evidence also showed that when petitioner left the former home he was carrying a shoe box, which contained a bullet and crack cocaine. See Riehl v. State, 660 So.2d 678 (Fla.1995) (holding that even though defendant did not testify, where the defendant and State presented evidence on the issue of intent and the State admitted the defendant told authorities that defendant had not intended to kill the victim, evidence was legally sufficient to sustain his conviction for premeditated murder). With respect to the conspiracy charge, the record reveals that the State did not introduce any evidence that petitioner was the initiator of a conspiracy. However, the State presented evidence that petitioner had agreed to drive to the former residence, to help dispose of the body, and that he did help dispose of the body after he killed the victim. See Asay v. State, 769 So.2d 974 (Fla.2000) (holding that whether a conspiracy was proven beyond a reasonable doubt is determined by the nature of the agreement that is established and the testimony, or other evidence, that is adduced at trial). Based on this evidence, the jury could have reasonably inferred that petitioner agreed to dispose of the body together with Powell and McDonald. See id. at 978. Accordingly, this Court concludes that the trial court correctly found that the evidence was legally sufficient to support the convictions for premeditated murder and conspiracy. See id. at 977. Petitioner also challenges the trial court's written order denying petitioner's motion for postconviction relief, arguing that the order is deficient because it does not specifically address the issue of newly discovered evidence. This Court has previously held that the trial court's failure to make specific findings on postconviction claims does not render the court's order deficient where the court's oral ruling on the claims is sufficient. See Johnson v. State, 927 So.2d 1053, 1054 (Fla. 4th DCA 2006). In the instant case, the trial court held that the newly discovered evidence was insufficient to support a new trial because the evidence was relevant and material only to the issues of competency and ineffective assistance of counsel.
